## INTRODUCTION AND OBJECTIVES

The University of Medicine, Pharmacy, Science and Technology of Târgu Mureș jointly with the European Commission organize the Conference *Stronger together: Building up security through cooperation, health, research and innovation*, which will take place on 12 June 2019, in Târgu Mureș, Romania.

The Conference contributes to EaP 20 deliverables by 2020 D12- Stronger governance – stronger security cooperation D 20 – Stronger society – Integrate Eastern Partnership and EU research and innovation systems and programs.

Building security is one of the main concepts in defining the state's role towards its citizens. The concept seen in a multidisciplinary manner implies good governance which in a global world cannot be seen as a mere national problem. Linking this concept to research, innovation and health generates a cascade of reverberations that are mainly translated in the concept of human security. Social development is influenced by many factors, from economic, social, legal to educational or research and all are embodied in public policies. Internationally, building security is done by laws, cooperation, exchange of good practices and grants which stimulate research and innovation.

When addressing research and innovation problems, the EU and Eastern Partnership countries face similar issues and challenges, acknowledging that in the EU there are better financed research systems and better chances in accessing EU funds. The main challenges remain the same and cooperation is a fundamental key in increasing the output of research. In this field the role of a sound and well financed educational and research system is crucial, and Universities play a central role. The digital era offers new opportunities by reducing distances and better connecting institutional actors involved in education, research and innovation with output in many fields including health. This opens up the path towards a more homogenous approach in constructing partnerships and research projects with national, regional and international impact.

In this context, the conference aims to gather policy makers, academia and researches from the EU and Eastern Partnership countries to build upon EaP deliverables by 2020 and Romanian presidency priorities. By linking research and innovation and, further on, the manner in which they can influence the process of building up security generates a synergic approach that universities, in collaboration with public and private entities, can develop.

The detailed action plan is developed around these 7 main pillars: Policy and governance; Main research priorities; Sharing knowledge; Building research networks between EU and EaP countries; Funding opportunities; Connecting national security and health; Cooperation in facing health regional problems

The Conference will count on guest experts from the European Union Member States and speakers from academia.

Participants of the Conference are experts, academia and officials from Ministries of Education, Health, Research, public employment agencies, research centres and civil society from the six countries of the Eastern Partnership. Total number of participants: 40 representatives from the Eastern Partnership countries and EaP Civil Society Forum; representatives from EU Member States, European Commission, academia.
