# **OPENING CEREMONY**

# Mr. LI Yong

Director General, United Nations Industrial Development Organization

Mr. LI Yong, Director General of the United Nations Industrial Development Organization (UNIDO), has had an extensive career as a senior economic and financial policymaker. As Vice-Minister of Finance of the People's Republic of China and a member of the Monetary Policy Committee of the Central Bank for a decade, Mr. LI has long been involved in setting and harmonizing fiscal, monetary and industrial policies and in supporting sound economic growth in China. Throughout his career, he has advocated financial-sector reform and prompted major financial institutions to establish corporate governance, deal with toxic assets and strengthen risk management.



Mr. LI prioritizes fiscal and financial measures to promote agricultural development and small and mediumsized enterprises, both of which represent cornerstones for creating economic opportunities, reducing poverty and promoting gender equality. He played a key role in China's cooperation with multilateral development organizations, such as the World Bank Group and the Asian Development Bank.

Vice Minister, Foreign Economic Policy and European Integration, Federal Ministry of Science, Research and Economy, Austria

Ms. Bernadette Gierlinger worked for nearly two decades in tax law and finance, with positions in both private firms and public departments. From 2002 until 2005, she held the position of Deputy Director of Finance at the Federal Ministry of Finance where she coordinated tax policy, prepared government bills and oversaw the calculation of implementation costs. Ms. Gierlinger has held the position of Vice Minister for Foreign Economic Policy and European Integration at the Federal Ministry of Science, Research and Economy since 2010. Her main responsibilities include coordinating foreign trade and investment policy, trade promotion and bilateral issues, as well as acting as Austria's representative in the European Union Trade Policy Committee. Ms. Gierlinger holds a master's degree in Business Informatics and Computer Science from the University of Vienna in Austria.

#### H.E. Mr. Sheikh Abdulla Rashid al Khalifa

Governor, Southern Governorate, Kingdom of Bahrain

H.E. Mr. Sheikh Abdulla Rashid al Khalifa is currently a committee member of the National Anti-Drug Committee in Bahrain and president of the Anti-Violence and Addiction programme, in addition to his duties as Governor of the Southern Governorate. He also leads the "Maan" programme to fight violence and addiction. He completed his Master of Business Administration and his Bachelor of Science at Bentley University in Waltham, MA.



# Mr. Jorge Chediek

Envoy of the United Nations Secretary-General on South-South Cooperation; Director, United Nations Office on South-South Cooperation

Mr. Jorge Chediek is the Director of the United Nations Office for South-South Cooperation, leading the promotion and coordination of South-South cooperation for development within the United Nations system. From 2010 to 2015, he served as Resident Coordinator and Resident Representative of the United Nations Development Programme (UNDP) in Brazil. In that capacity, he was also the Director of the International Policy Centre for Inclusive Growth, UNDP's global forum for South-South dialogue on innovative social development policies. Mr. Chediek holds a master's degree in Foreign Service from Georgetown University in Washington, D.C.

# Mr. CAI E-Sheng

Chairman, Finance Center for South-South Cooperation (FC-SSC), Hong Kong, China

Mr. CAI E-Sheng serves as Chairman of the Finance Center for South-South Cooperation and has served as Executive Director of the China Society for Finance and Banking since 2014. Mr. CAI joined the People's Bank of China (PBC) in 1975 where he served as Assistant to the Governor from 1998 and Governor of the PBC Shanghai Branch from 2000. He then acted as Chairman of the Supervisory Board for the China Everbright Group and the Citic Group Corporation beginning in 2001. From 2005 to 2013, he worked as Vice Chairman of the China Banking Regulatory Commission. He was elected a member of the Chinese People's Political Consultative Conference in 2013. Mr. Cai holds a bachelor's degree in Economics from Shanxi University of Finance and Economics in China.

#### Ms. Shamshad Akhtar

Executive Secretary, United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP)

Ms. Shamshad Akhtar was appointed Under-Secretary-General of the United Nations and the tenth Executive Secretary of the Economic and Social Commission for Asia and the Pacific by United Nations Secretary-General Ban Ki-moon in December 2013. Formerly the Secretary-General's Senior Adviser on Economics and Finance and Assistant Secretary-General for Economic Development at the Department of Economic and Social Affairs, she led the UN-wide coordination of the post-2015 development agenda. Ms. Akhtar has previously served as Governor of the Central Bank of Pakistan and as Vice President of the Middle East and North Africa Region of the World Bank.

Ms. Akhtar holds a PhD in Economics from Scotland's Paisley College of Technology, as well as a master's in Development Economics from the University of Sussex in the United Kingdom and an MSc in Economics from Quaid-e-Azam University in Islamabad.

# Mr. ZHU Shanzhong

Executive Director, World Tourism Organization

Mr. ZHU Shanzhong is in charge of the overall supervision of Technical Cooperation and Services and Special Field Programmes at the World Tourism Organization, accounting for the formulation, approval and implementation of their activities in the development and promotion of the tourism industry as an engine for socioeconomic growth and poverty alleviation. From late 2008 to 2013, he was Vice Chairman of the China National Tourism Administration (CNTA), overseeing international relations, marketing and promotion in domestic and overseas markets, tourism security, and the establishment of a public service network. From 1989 to 2008, he served CNTA in different capacities, namely as Director of the CNTA Sydney Office, Director of the CNTA New York Office, Deputy Director General of the International Marketing Department and Director General of the Marketing and Communication Department. From 1985 to 1989, he was Department Manager of the China International Travel Service, the largest travel company in China.

Mr. ZHU received his master's degree in Tourism Economic Management from the New School in New York. Prior to that, he received his Bachelor of Arts in English Language and Literature from Nanjing University in China.

Mr. Philippe Scholtès is Managing Director of Programme Development and Technical Cooperation at the United Nations Industrial Development Organization (UNIDO). At UNIDO Headquarters in Vienna, he oversees UNIDO's technical assistance programmes – a portfolio of over 700 projects totaling one billion dollars, being implemented by 220 staff and over 1,200 project personnel in a hundred countries. Prior to this, Mr. Scholtès was Director of UNIDO's Agribusiness Development Department. He also served as UNIDO Representative in Viet Nam and as Regional Director for South Asia in New Delhi, India.



Mr. Scholtès is a Belgian national and holds a Master of Science in Engineering (majoring in electromechanics) and a Master of Science in Economics (majorin in mathematical economics). He has published articles on economics, energy economics and industrial organizations, among other areas, in several peer-reviewed journals.

# Mr. Peter Frankopan

Director, Oxford Centre for Byzantine Research; Senior Research Fellow, Worcester College, University of Oxford, United Kingdom

Mr. Peter Frankopan is a historian at the University of Oxford, specializing in global history, the life of cities, exchanges of faith, ideas, goods and language across Asia and between Asia and Europe, particularly along the Silk Roads. His interests include the relationship between urban settlements and their hinterlands, the evolution of civic culture and how cities have changed in the past and will change in the future. Mr. Frankopan's new book, The Silk Roads: A New History of the World, was published in August 2015. It was a Sunday Times #1 Bestseller, topped the charts in India and China and was named The Daily Telegraph's History Book of the Year 2015. Mr. Frankopan holds a degree in History from Cambridge University and a DPhil from the University of Oxford.

Ms. Cristina Pinna works as Policy Adviser in the Policy and Partnership Unit-Global and Regional Cooperation Team in the United Nations Development Programme's (UNDP) China office. She is in charge of conducting policy research and strengthening partnerships to support China's positive engagement in global development and the implementation of the 2030 Agenda for Sustainable Development. In particular, she has been working to strengthen the UNDP flagship initiative on global governance, with a special focus on G20 issues, the One-Belt-One-Road initiative, BRICS and engagement with new financing institutions such as the Asian Infrastructure Investment Bank and the New Development Bank.

Prior to joining UNDP, Ms. Pinna collaborated as co-investigator for a United Nations Educational, Scientific and Cultural Organization pilot project with the Chinese University of Hong Kong. She worked as a research fellow at Peking University in China and as a policy analyst for the Italian Ministry of Foreign Affairs. Ms. Pinna holds a PhD in Political Science and International Relations from the University of Cagliari in Italy and conducted her postdoctoral studies at the University of Toronto.

# Mr. Michael Postl

Mr. Michael Postl has worked as Head of the Department for Foreign Economic Relations, Common Trade Policy, Export Promotion, Investment Agreements and International Financial Institutions at the Federal Ministry for Europe, Integration and Foreign Affairs since February 2012. He is also a lecturer at the University of Innsbruck in Public International Law and International Relations. Since September 2015, he has been the Austrian National Coordinator for the Central European Initiative.

Previous assignments include the Head of the Austrian Embassy for Armenia, Georgia and Uzbekistan and Austrian Ambassador in Tehran. Mr. Michael Postl holds a PhD in European, Constitutional and Public International Law from the University of Vienna in Austria.

# Mr. Renaud Sorieul

Director, International Trade Law Division, United Nations Office of Legal Affairs; Secretary of United Nations Commission on International Trade Law

Mr. Renaud Sorieul is the Director of the International Trade Law Division of the United Nations Office of Legal Affairs, which functions as the substantive secretariat for the United Nations Commission on International Trade Law (UNCITRAL). He is the eighth Secretary of UNCITRAL since the Commission was established by the General Assembly in 1966. Since he joined the UNCITRAL secretariat in 1989, he has been actively involved in the UNCITRAL Working Group on International Payments, which prepared the UNCITRAL Model Law on International Credit Transfers. He then served as Secretary of the UNCITRAL Working Group on Electronic Commerce, which drafted the UNCITRAL Model Law on Electronic Signatures.

Since 2002, he has been Secretary of the UNCITRAL Working Group on Arbitration and Conciliation.

A French national, Mr. Sorieul holds degrees in private law from the University of Paris (Paris II). He is also a graduate of the Institut d'études politiques de Paris and the École Nationale de la Magistrature.

#### Ms. Alla Peressolova

Head of UNWTO Silk Road Programme, World Tourism Organization

Ms. Alla Peressolova has worked at the World Tourism Organization (UNWTO) for over twenty years in different areas and is currently in charge of the UNWTO Silk Road Programme, creating a collaborative platform for effective activities to raise the profile of Silk-Road tourism and to support Silk-Road destinations in the development of responsible and sustainable tourism across Europe, Asia and the Middle East. Currently thirty-three countries are actively engaged in the Programme.



Prior to her current position, Ms. Peressolova was responsible for the UNWTO's relations with major international fairs. Over the years, she has established strong alliances with over twenty international and regional fairs, developing ongoing programmes and events. She oversaw several successful events, including the annual Ministers' Summit, which attracts over 100 ministers of tourism every year to the World Travel Market London. Among her other projects are numerous communications and awareness campaigns, international conferences and capacity-building workshops. Ms. Peressolova holds an undergraduate degree in English Philology and Linguistics and a postgraduate degree in Tourism Development Strategies and Marketing.

# Mr. Manuel Montes

Senior Adviser, Finance and Development, The South Centre, Switzerland

Mr. Manuel Montes is Senior Adviser on Finance and Development at the South Centre, an intergovernmental think tank created by and for developing countries. Mr. Montes works specifically on financing for development and the 2030 Agenda for Sustainable Development, investment treaties and tax cooperation, and industrial policy.

Mr. Montes was previously Chief of Development Strategies at the United Nations
Department of Economic and Social Affairs where he led the team that produced the World
Economic and Social Survey. He has previously worked as the United Nations Development Programme's
Regional Programme Coordinator for the Asia Pacific Trade and Investment Initiative based in Sri Lanka and as
Programme Officer for International Economic Policy at the Ford Foundation in New York.

Mr. Montes was Senior Fellow and Coordinator for economic studies at the East-West Centre in Honolulu from 1989 to 1999 and Associate Professor of Economics at the University of the Philippines from 1981 to 1989. He holds a PhD in Economics from Stanford University.

# Mr. SUN Xiaokun

Chairman, The Board of Supervisors, China-Africa Development Fund, China Mr. SUN Xiaokun has served at the China Development Bank (CDB) since 1994. During his time at the CDB, he has acted as Director of the New Protocol Implementation Office, Deputy Director of the Risk Management Authority, Deputy Director of the Information Technology Bureau and Deputy Director of the Personnel Bureau. He has extensive experience with mid-long-term credit management and risk management.

Mr. SUN graduated from the Management School of Fudan University with a Bachelor of Science and holds a master's degree in Economy from Jinan University.



#### Mr. Ahmed M. Darwish

Chairman, General Authority for Suez Canal Economic Zone, Egypt

Mr. Ahmed M. Darwish was Minister of State for Administration Development from 2004 to 2011. While in this position, he oversaw three major portfolios: e-government, institutional and human-resource development, and governance institutionalization. His work in this area has been internationally recognized. The Government of Egypt's electronic and web services ranked 23 out of 192 countries according to a 2010 report produced by UN-PAN, and the program received the best service award both from the United Nations in New York and the African Union in Johannesburg.



Mr. Darwish is a consultant for a number of international organizations, including UNDP, UNIDO, UNESCO, FAO, ESCWA, the European Union and the World Bank, government organizations, and companies in the Middle East, Africa, Europe and the United States. He received his Bachelor and Master of Science from Cairo University and completed his PhD in Computer Engineering at the University of California, Davis.

# Mr. Stephen Perry

Chairman, 48 Group Club, United Kingdom

Mr. Stephen Perry is the Chairman of the 48 Group Club, which promotes positive trade and other relations between the United Kingdom and China. He pioneered the Young Icebreakers, which works to advance the Club's aim among young entrepreneurs. Mr. Perry has made over 200 trips to China and negotiated many joint ventures with a value in excess of one billion dollars. He is the Vice Chairman of the China-Britain Business Council, a Fellow of University College London, a Trustee of the Needham Research Institute at Cambridge and a member of the Chairman's Organizing Committee of China.



# Mr. Ireneusz Jabłonski

Vice Mayor, Lodz, Poland

Mr. Ireneusz Jabłonski has been Deputy Mayor of the City of Lodz since 2015. He works as a specialist in the area of strategic and operational management, building, restructuring, and managing large businesses and public organizations. Since 2002, he has been Vice President of Bank Czestochowa SA, overseeing its restructuring and serving as Project Manager. As Vice President of Postbank, he has been responsible for the bank's restructuring and its innovative program to implement a wide range of financial services for postal institutions since 2003. Mr. Jabło ski graduated from the Technical University of Lodz and attended postgraduate studies in Banking at the Warsaw School of Economics.



### Ms. Gudrun Henn

Director, International Cooperation Projects and Technology Exports, Federal Ministry of Science, Research and Economy, Austria

Ms. Gudrun Henn has held the position of Director of International Cooperation Projects and Technology Exports at the Federal Ministry of Science, Research and Economy since 2002. Her work at the Federal Ministry focuses on foreign economic policy projects, technology exports, international environmental issues, global climate and environmental policy (coordinating the implementation of environmental legislation via voluntary agreements), national environmental affairs, and environmental engineering. 

# **Keynote Speaker**

Mr. Gerhard O. Braun

Professor, Institute for Geographical Sciences, Free University of Berlin, Germany

Mr. Gerhard O. Braun graduated from the University of Würzburg with a degree in Geography, Mathematics and Psychology. After five years as Assistant Professor, Mr. Braun was hired by the University of Frankfurt in 1974, and in 1975, by the Free University Berlin as Professor for Urban Studies, Geographic Information Science and Statistics. In 2009, he founded the Institute for International Urban Studies at the International Academy Berlin. For some twenty years, he has been invited as a guest professor at Wilfrid Laurier University in Waterloo, Canada.

# Ms. Tanja Wehsely

Member, Vienna Parliament; Member, Vienna City Council, Austria

Ms. Tanja Wehsely acts as Chairperson of the Committee for Finance, Economy and International Affairs, a Member of the Committee on Women, Education, Youth, Integration and Personnel, and a Member of the Committee on Housing, Residential Construction and Urban Renewal in her current positions as a Member of the Vienna Parliament and Vienna City Council. Prior to her current position, she was a lecturer on lobbying and public affairs at St. Pölten University of Applied Sciences. She has also worked in the area of public relations for the Association of Viennese Youth Centres. She holds a Magister degree in Social Sciences from St. Pölten University of Applied Sciences.



### Mr. Alexandr Aleksandrovich Zhilkin

Governor, Astrakhan Region, Russian Federation

Mr. Alexandr Aleksandrovich Zhilkin became the first Deputy to the Head of Astrakhan's regional administration in 1991. His main areas of work included new economic policy, in particular fostering the development of emerging economic sectors in order to fight unemployment. During this same time, Mr. Zhilkin presided over the inter-banking council. Due to the stabilization of the financial system, which he and his co-workers facilitated, the 1998 Russian financial crisis affected Astrakhan to a much lesser degree than other regions of the country. In August 2004, he became Acting Governor of the Astrakhan Region and went on to win the elections for Governor in December of that same year.



Mr. Zhilkin studied Physics and Mathematics at Astrakhan Pedagogical Institute. He later acquired a postgraduate degree in Economics and became Associate Professor at Astrakhan State University. Shortly following his instatement as Governor, he completed his PhD in Biological Sciences.

# Ms. Francesca Cangelli

Deputy Mayor, Matera, Italy

Ms. Francesca Cangelli is currently Associate Professor in Administrative Law at the University of Foggia. Since 1999, she has been a member of the Italian Association of Planning Law and has participated as rapporteur in several congresses. She is a member of the editorial staff of the Italian journal "Comparative Public and European Law". Ms. Cangelli holds a law degree from Libera Università Internazionale degli Studi Sociali in Rome and a PhD in Administrative and Public Law from the University of Ferrara.



# Mr. HANG Dong

Vice Mayor, Fuzhou, China

Mr. HANG Dong is in charge of domestic trade, the rectification and standardization of the economic order, investment promotion, foreign economy and trade, overseas affairs (including Hong Kong, Macau and Taiwan), the 21<sup>st</sup> Century Maritime Silk Road, and food security, industry and commerce in the Municipality of Fuzhou.


