

AgenT is a diagnostics company developing the first blood test to diagnose Alzheimer's disease before symptoms develop.

Current diagnostics tools available (PET scan and lumbar puncture) are invasive with low sensitivity and specificity for screening Alzheimer's during the predementia stages when it can be prevented.

AgenT's blood test combines Machine Learning and patented multi-omics biomarkers to rapidly and accurately diagnose pre-dementia Alzheimer's.

During the first clinical proof of concept on 232 human blood samples, the best algorithm achieved 98.1% sensitivity and 98.8% specificity.



Nanoligent is a preclinical stage drug discovery company based in Barcelona. It is a spin-off of two academic groups from the top biotech and life science hub of Spain.

Cancer is the second leading disease being responsible for an estimated 10 million deaths in 2020 globally. Metastasis, the process by which a tumor cell escapes from the primary tumor and colonize distant organs, is the main cause of patient death in most tumor types

Current treatments are mainly focused on the constrain of the primary tumor but not on metastasis.

One important mechanism used by tumor cells to become metastatic is the overexpression of the CXCR4 receptor. It occurs in more than 40% of the patients of 23 types of different types of metastatic cancers and correlates with a very poor prognosis for these patients.

Nanoligent has developed a drug able to kill very efficiently those CXCR4+ cancer cells responsible for spreading metastasis without affecting non-tumor tissues, based on a new biotechnological platform.
