





Plastic reducing pioneers

Many initiatives designed to tackle some of these items already exist at municipal level. These pioneers are showing that life without single use is possible, but need EU legislation to support on a larger scale.

- Munich public authorities ban on disposable drink containers and tableware since 1990
- Freiburg: reusable, standardised coffee cup that can be returned to any participating store
- Hong Kong: replacing plastic straws with wood pulp straws
- Copenhagen: 60 drinking water fountains installed to encourage the use of refillable bottles

European citizens want and expect EU legislation

- Plastic bag directive was highly effective where implemented, and also very popular with citizens
- Targets to reduce other single-use items should also be tabled
- Return deposit schemes for beverage bottles enjoy high public acceptance and could be made obligatory
- Other areas for EU intervention include setting mandatory Green Public
 Procurement rules which prioritise waste prevention and reuse in catering
- Citizens are demanding action on plastic! Public petition calling on the Commission to produce an ambitious strategy.
