## Vision of paperless cross-border trade



Technical pilots under EU4Digital Facility | eTrade cover:

- Exchange of electronic data CEF Building Blocks (eDelivery, elnvoicing)
- Faster border crossing and delivery of goods advanced mechanisms for customs information exchange (SEED)
- Eliminating obstacles for cross-border electronic commerce eCommerce pilot
- eLogistic data flows across the physical transport corridor from Baltic to Black Sea action
  plan for piloting Digital Transport Corridor

# eDelivery pilot

eDelivery pilot will test the ground for **paperless information exchange** in selected Eastern partner countries using established **EU-wide solution and standards**.


Solution to be piloted: CEF eDelivery Building Block

**Use case:** invoice data exchange between cross-border trade partners in Peppol eDelivery Network

Geographical scope: Ukraine - Poland

Current progress: testing phase has started and trainings

Launch: 9 October 2020

Imports and receives eInvoice UA


## eCustoms pilot

Customs information exchange pilot will facilitate customs-to-customs timely data exchange and demonstrate the improvement in release time of goods as well as introduce advanced customs risk management processes.


The pilot will be performed between selected border crossing points of Belarus and Lithuania.

**Three data exchange related** scenarios are planned to be piloted using SEED (Systematic Electronic Exchange of Data) solution:

- Empty Trucks
- Exchange of exit data from transit/export declarations (limited data set)
- ► Full declaration data set from the transit and export declarations for volunteers
