Data Protection Notice for the Cross Border Transport Conference

November 14th 2019, Brussels

Your personal data is processed in accordance with **Regulation (EU) No 2018/1725¹** on the protection of individuals with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

The data controller of the processing operation is:

Head of Unit D2 Interreg Cross-Border Cooperation Internal Borders of DG Regional and Urban Policy, European Commission. REGIO-D2-CROSS-BORDER-COOPERATION@ec.europa.eu. The following **entities process** your personal data on behalf of the data controller:

- ICF NEXT.

These entities process your personal data in accordance with Regulation (EU) No 2018/1725 or Regulation (EU) 2016/679, respectively.

The legal basis for the processing activities are:

- Article 5(a) of Regulation EU 2018/1725 because processing is necessary for the performance of a task carried out in the public interest (or in the exercise of official authority vested in the Union institution or body)²;
- Article 5(d) of Regulation EU 2018/1725 based on your explicit consent for your non-mandatory personal data indicated below.

The purposes of this processing are to: register and manage your participation to a Conference on Cross Border Transport through Aventri platform; provide you with access to the event venue; include you in the list of participants; allow networking among participants; inform the participants about follow-up activities of the event/related to the topic of the event, including feedback collection and specific, related communication activities.

The following of your personal data are collected: your first name, last name, title, date of birth, ID number, e-mail address, phone number, address are **mandatory** for the purposes outlined above.

In addition, the following **non-mandatory** personal data are collected: your photo and videos, which can only be processed based on your explicit prior consent. It is indeed possible that **photographs** of you will be taken during the event and might be used for related communication purposes, including on Internet and social media such as Twitter and Facebook³. Upon registration, you can give your explicit consent to have your images recorded and published on related communication channels⁷. In the absence of your consent, the organiser will offer suitable alternatives, so that you can fully take part in the event.

The recipients of your personal data will be DG Regio and Commission staff in charge of the management of the Conference on Cross Border Transport, staff of ICF Next in charge of organising the conference, agents of the security personnel, participants of the conference as well as the public and bodies charged with monitoring or inspection tasks in application of EU law (e.g. internal audits, Court of Auditors, European Anti-fraud Office (OLAF)).

Your personal data **will not be transferred** to third partners or international organisations.

The processing of your data will **not include automated decision-making** (such as profiling).

Your personal data will be kept for a maximum period of **36** months from 14/10/2019 to 14/10/2022. Data will be deleted at the end of this period.

You have the right to access your personal data and to request your personal data to be rectified, if the data is inaccurate or incomplete; where applicable, you have the right to request restriction or to object to processing, to request a copy or erasure of your personal data held by the data controller. If processing is based on your consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of the processing based on your consent before its withdrawal.

Your request to exercise one of the above rights will be dealt with without undue delay and within **one month**.
