Moving forwards, we recognise the budget situation at WAGGS and we seek a solution that will enable the continued growth and success achieved in the Africa region.

We seek to look at ways that we can achieve the Africa region strategy, including the possibility of allocating the available budget in different ways, and embracing partnerships and collaboration.

The conference requests the World Board, in partnership with the Africa Committee, to explore and provide feedback and options to have a strong structure that may include:

- Staff to support the Africa Committee with strategic planning
- Staff to support with relationship management with the Members
- Possibility to have an office located in Africa

We ask that there is enhanced partnership and improved communication between MOs, Africa Regional Committee and the World Board in order to ensure that Africa is able to deliver on its mandate.
