# 1. BACKGROUND

Geneva Peace Week (GPW) is a flagship initiative of the Geneva Peacebuilding Platform (GPP) in collaboration with the Graduate Institute of International and Development Studies (IHEID), the United Nations Office at Geneva (UNOG), and the Platform's five partners – the Graduate Institute's Centre on Conflict, Development and Peacebuilding (CCDP); DCAF - Geneva Centre for Security Sector Governance; the Geneva Centre for Security Policy (GCSP); Interpeace; and the Quaker United Nations Office, Geneva (QUNO), with the support of Switzerland.

Geneva Peace Week is a leading annual forum in the international peacebuilding calendar in which organizations in Geneva and their international partners come together to share knowledge and practice on a diverse range of topics relating to the promotion of peace across contexts and disciplines.

The *GPW Final Report* provides key data including highlights of programmatic successes and innovations. This report is intended to contribute to the ongoing reflections about improving GPW in 2023, especially in anticipation of the 10th anniversary of the Geneva Peace Week as well as to a strategic review.

# 2. GENEVA PEACE WEEK 2022

GPW22 took place from 31 October to 4 November 2022 at the Maison de la Paix Campus, in facilities of the Geneva Graduate Institute, the Geneva Center for Security Policy and the Geneva Graduate Institute's Conference Center. After two editions that were held almost fully online due to the global pandemic (in 2021, the Opening and Closing ceremonies were held in hybrid), considerable efforts have been made to offer as many traditional in person events as possible while keeping some sessions online to retain the reach and expansion that was successfully achieved in prior editions.

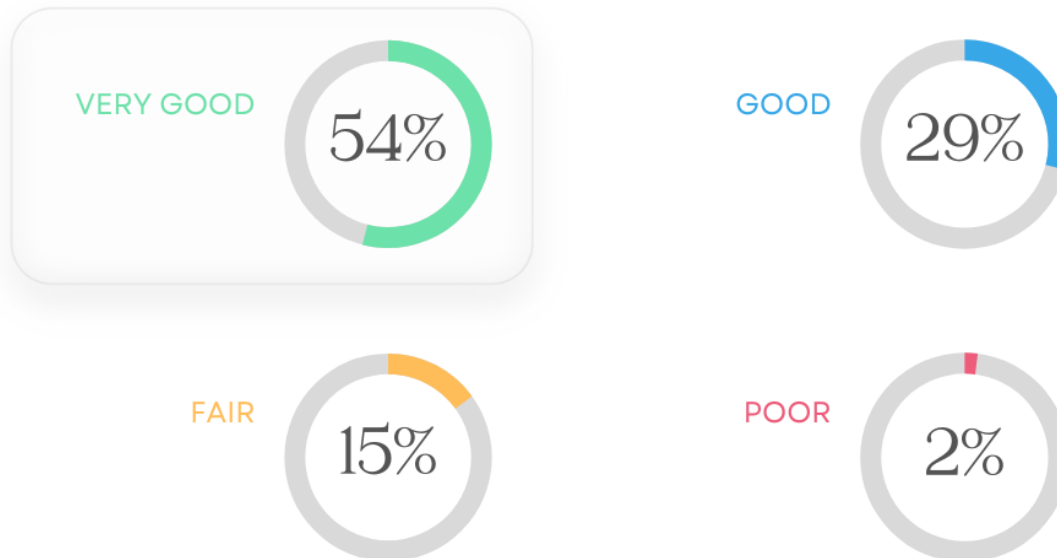


## A. GPW22 KEY FIGURES

## B. THEMATIC PROGRAMME

The programme was developed through an inductive process beginning with the review of 92 session applications received in June 2022, based on the overarching theme “Peace is possible”. As with other years, these applications offered an opportunity to identify innovative practice and key thought leadership in peacebuilding across the world. The very high quality of the applications led to the elaboration of a full programme developed along four thematic tracks:

1. Rights, inequalities and peace: Navigating tensions, finding opportunities
2. Moving beyond securitization: Risk management and new horizons for peacebuilding
3. Digital peace: The power and limits of innovation in peacebuilding
4. Cultivating cooperation: Environmental challenges and opportunities for peace in a new age of insecurity

### a. Opening day and closing session

Organised by the GPP in partnership with the GCSP and Principles for Peace, the opening day, composed of five panels, took place on Monday 31 October 2022 and welcomed a prestigious array of guests to discuss the overarching theme “Peace is possible”:

It was moderated by **Hiba Qasas** of Principles for Peace.

Another special event was organised by the **Principles for Peace initiative**, a global participatory initiative to develop a new set of principles, standards and norms that will fundamentally reshape how peace processes are structured, sequenced and actualized. Among their invited guests, two ambassadors joined the discussion, namely, **Amb. Anna Jardfelt**, Permanent Representative of Sweden to the International Organisations in Geneva, and **Amb. Hans-Peter Jugel**, Deputy Permanent Representative of Germany to the International Organisations in Geneva.

The day closed with the GPW22 Opening Ceremony that included official addresses from **Amb. Jürg Lauber**, Permanent Representative of Switzerland to the United



Nations and other International Organizations in Geneva and **Tatiana Valovaya**, Director-General of the United Nations at Geneva via video message. The session continued with a conversation with **Volker Türk**, the United Nations High Commissioner for Human Rights, for his first public intervention since he took up his official functions on 17 October 2022. The ceremony ended with a panel discussion between **Margot Wallström**, Chair of the Environment of Peace initiative, former Swedish Minister for Foreign Affairs and European Commissioner for the Environment and UN Special Representative on Sexual Violence in Conflict, **Hina Jilani**, Member of the Elders, Lawyer and Civil Society Activist, Leading Activist in Pakistan's women's movement and international champion of human rights (online) and **Achim Wennmann**, Director of Strategic Partnerships at the Geneva Graduate Institute.

The Closing Session took place on Friday 4 November 2022 and featured a conversation with **Fionnuala Ní Aoláin**, the UN Special Rapporteur on the promotion and protection of human rights and fundamental freedoms while countering terrorism, based on her latest report *Promotion and protection of human rights and fundamental freedoms while countering terrorism* (September 2022). Track leads, **Florence Foster**, Representative for Peace and Disarmament at the Quaker United Nations Office, **Annika Erickson-Pearson**, Community Management Lead at the Geneva Peacebuilding Platform, **Dr. Andreas Hirblinger**, Postdoctoral Researcher at the Center on Conflict, Development and Peacebuilding, Geneva Graduate Institute and **Dr. Annysa Bellal**, Executive Coordinator of the Geneva Peacebuilding Platform closed the GPW with a wrap up of key messages and topics discussed throughout the week in front of an audience of 72 attendees.

## b. High Level Panels

From Tuesday to Thursday, the GPP and other core partners such as the CCDP, QUNO or Alp Analytica, organised 3 high level panels under the impulse of the GPW track leads, namely **Florence Foster**, **Oli Brown & Annika Erickson-Pearson** and **Dr. Andreas Hirblinger**, on the following tracks: Cultivating cooperation: Environmental challenges and opportunities for peace in a new age of insecurity, Digital peace: The power and limits of innovation in peacebuilding and Rights, inequalities and peace: Navigating tensions, finding opportunities. An average of 70 persons attended each of these events.

## c. Workshops

One of the innovations of the 2022 edition was the emphasis on interactive sessions. Partner organizations were invited to design workshops that were practitioner-led and interactive, with the aim of offering attendees the opportunity to exchange and share knowledge, good practices, and peacebuilding skills to apply in their daily work. It was recommended that organisers ensure input from speakers be less than 50% of the session time and to foster, to the extent possible, small working groups to achieve goals set by the application criteria. In total, 16 workshops took place in person while 18 occurred online.



## In person workshops

In person workshops took place either at the Conference Center or at the GCSP. Due to room capacity but also considering the workshop modalities, attendance was limited to in-person only with a maximum of 40 participants per session, with the possibility to accept last minute participants on a first come first served basis. Attendees' selection was conducted by organisations leading each workshop prior to the start of the GPW.

### **d. Digital Series**

The 2022 Digital Series features 21 contributions, in which organisers developed their peacebuilding expertise, research, and stories into short, educational and digital formats (videos, podcasts, and other media). The Digital Series format was adapted for the GPW22 edition to bring focus on information-sharing that is concise, but in-depth, with the goal of educating online audiences on peacebuilding topics related to GPW22. The Digital Series contributions are broadcasted on the GPW website and major streaming platforms (including [YouTube](#) and [Spotify](#) etc.). The Series offers an opportunity for contributions to continue beyond Geneva Peace Week, across geographical, cultural and temporal borders. As of 11 January 2023, the Digital Series generated more than 1900 streams.

2 online sessions called “Selected Digital Series” were organised during GPW22, designed to give GPW attendees the opportunity to meet and interact with organisations that contributed to the series, with an average of 30 attendees per session.

### **e. Side events**

#### **Kofi Annan Geneva Peace Address**

The Kofi Annan Foundation, the Geneva Graduate Institute and the Geneva Peacebuilding Platform organised the second edition of the Kofi Annan Geneva Peace Address, a high-level lecture on peace held every year as part of Geneva Peace Week.



This Address was delivered by **Elena Zhemkova**, Co-Founder and Executive Director of the Russian human rights organisation Memorial, recently awarded the Nobel Peace Prize for 2022.
