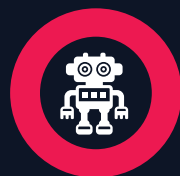
Ocean Rig

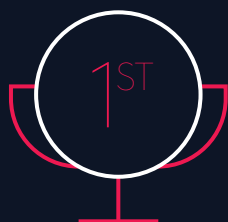
